- Vincent Bruyère, Assistant Professor in the Department of French and Francophone Studies, will conduct research while in Canberra, Australia for his project "Sense of Survival: Literary Studies in the Age of Environmental Cosmopolitics."
- Alison Eisel Hendricks, Department of Germanic and Slavic Languages and Literatures, will conduct additional research on the preservation of the minority language Fering for her dissertation "Quality and Quantity of Language Input: North Frisian Child Second Language Acquisition."

Graduate Research in Global Studies: A Series of Brown Bag Talks

The Center for Global Studies Brown Bag Lecture Series concluded in April with talks by Kevin Lowe, CGS Fellow and doctoral candidate from the Department of History and Sara Marzioli, PhD candidate from the Department of Comparative Literature.

Lowe discussed the ways in which U.S. missionaries became involved in international efforts to develop agriculture and rural life post-World War II during his lecture entitled "Building the Kingdom in the Countryside: Christian Missionaries, Agriculture, and Globalization" while Marzioli spoke about the research she has conducted both in Italy and the U.S regarding the engagements of African-American intellectuals with political and cultural forms of black internationalism. Her talk entitled "Invisible Diasporas: Afro-Modernism in Italy" introduced the audience to twentieth century African-American and Italian writers and film directors whose work address the dialectic between historiography and fiction as well as racial relations and modernity.
